

AN ORDINANCE REQUIRING THE POSTING OF STREET NUMBERS ON ALL HOMES, BUILDINGS AND MOBILE HOMES WITHIN THE CORPORATE LIMITS AND POLICE JURISDICTION OF THE TOWN OF BROOKWOOD, ALABAMA, AND TO PROVIDE FOR THE ENFORCEMENT OF SAID ORDINANCE AND TO PROVIDE PENALTIES FOR ITS VIOLATION THEREOF.

ORDINANCE #95-137

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF BROOKWOOD, ALABAMA, AS FOLLOWS:

SECTION ONE. PURPOSE.

To assist law enforcement, fire and rescue personnel in locating addresses when on calls; to shorten response times; and to provide for the protection of law enforcement, fire and rescue personnel when answering calls.

SECTION TWO. POSTING STREET NUMBERS.

It shall be the duty of all owners, residents, or agents of real estate in the corporate limits of the town of Brookwood, Alabama, to have their residences, mobile homes, businesses or other buildings numbered according to the United States Postal Service.

The numbers shall be at least three inches tall and shall be posted on the home, building or mobile home immediately adjacent to the front door on the righthand side as you face the front door at a height of six feet above the level of the bottom of the door. The posted number shall contain only the street number. No street, highway or subdivision names shall be included. The numbers used may be of any type material but must be clearly visible from the street.

SECTION THREE. POLICE JURISDICTION.

The provisions of this ordinance shall apply equally in the police jurisdiction of the town of Brookwood as in the corporate limits.

SECTION FOUR. FUTURE ANNEXATIONS.

The provisions of this ordinance shall apply to any property that is annexed into the corporate limits of the

town of Brookwood or which may lie in any expanded police jurisdiction as the result of any future annexations. Upon future annexations, any property affected by this ordinance shall be posted with its street number within thirty days of the effective date of the annexation.

SECTION FIVE. NEW CONSTRUCTION.

The provisions of this ordinance shall apply to any new construction or the locating of a new mobile home within the corporate limits or police jurisdiction of the town of Brookwood, Alabama. Any new construction or location of a new mobile home shall be posted within thirty days of the completion of construction or the location of the mobile home.

SECTION SIX. PENALTY.

Any person violating any provision of this ordinance shall, upon conviction, be punished by a fine of \$25.00 per occurrence. Each day beyond the applicable grace period shall constitute a separate occurrence.

SECTION SEVEN. GRACE PERIOD.

Except as otherwise provided, there shall be a grace period of thirty days from the effective date of this ordinance to allow owners, residents and agents to post the street numbers.

SECTION EIGHT. SEVERABILITY.

Each and every provision of this ordinance is hereby declared to be an independent provision, and the holding of any provision hereof to be void or invalid shall not affect any other provision hereof, and it is hereby declared that the other provisions of this ordinance would have been enacted regardless of any provision which might be held invalid.

SECTION NINE. EFFECTIVE ENFORCEMENT.

The provisions of this ordinance shall be in effect and be enforced at all times. This ordinance shall become effective when adopted and published as required by law.

BROOKWOOD TOWN COUNCIL:

RE: ADDRESS ORDINANCES

COUNCIL MEMBER,

WE WISH TO BRING TO YOUR ATTENTION A PROBLEM WHICH ALL EMERGENCY PERSONNEL ARE FACED WITH. THIS PROBLEM IS CONCERNING LOCATING THE CORRECT PLACE OF EMERGENCY CALLS. ONCE WE ARE DISPATCHED, AND ARRIVE AT A GENERAL LOCATION, WE CAN'T FIND THE RESIDENCE. THIS PROBLEM DOES NOT ONLY EXIST IN THE POLICE DEPARTMENT, BUT ALSO IN THE FIRE, RESCUE AND COUNTY SHERIFF'S DEPARTMENTS. MINUTES COUNT WHEN ITS AN EMERGENCY SITUATION. THERE IS ALSO A GREATER DANGER. THE DANGER WHICH THE POLICE OFFICER FACES, WHEN HE CAN'T FIND THE CORRECT LOCATION. FOR EXAMPLE, THE OFFICER RECEIVES A CALL REPORTING A MAN WITH A GUN, UNABLE TO FIND THE LOCATION, HE STOPS TO ASK DIRECTIONS AT THE MAN'S HOUSE.

THIS PROBLEM COULD BE SOLVED BY THE TOWN COUNCIL, PASSING AN ORDINANCE REQUIRING EVERYONE TO POST THE FIVE DIGIT ADDRESS ON THE OUTSIDE OF THEIR HOME. WE REQUEST THE ENTIRE POLICE JURISDICTION BE INCLUDED IN THIS ORDINANCE. THIS WILL HELP EVERYONE.

THE FOLLOWING ITEMS SHOULD BE INCLUDED IN THE ORDINANCE:

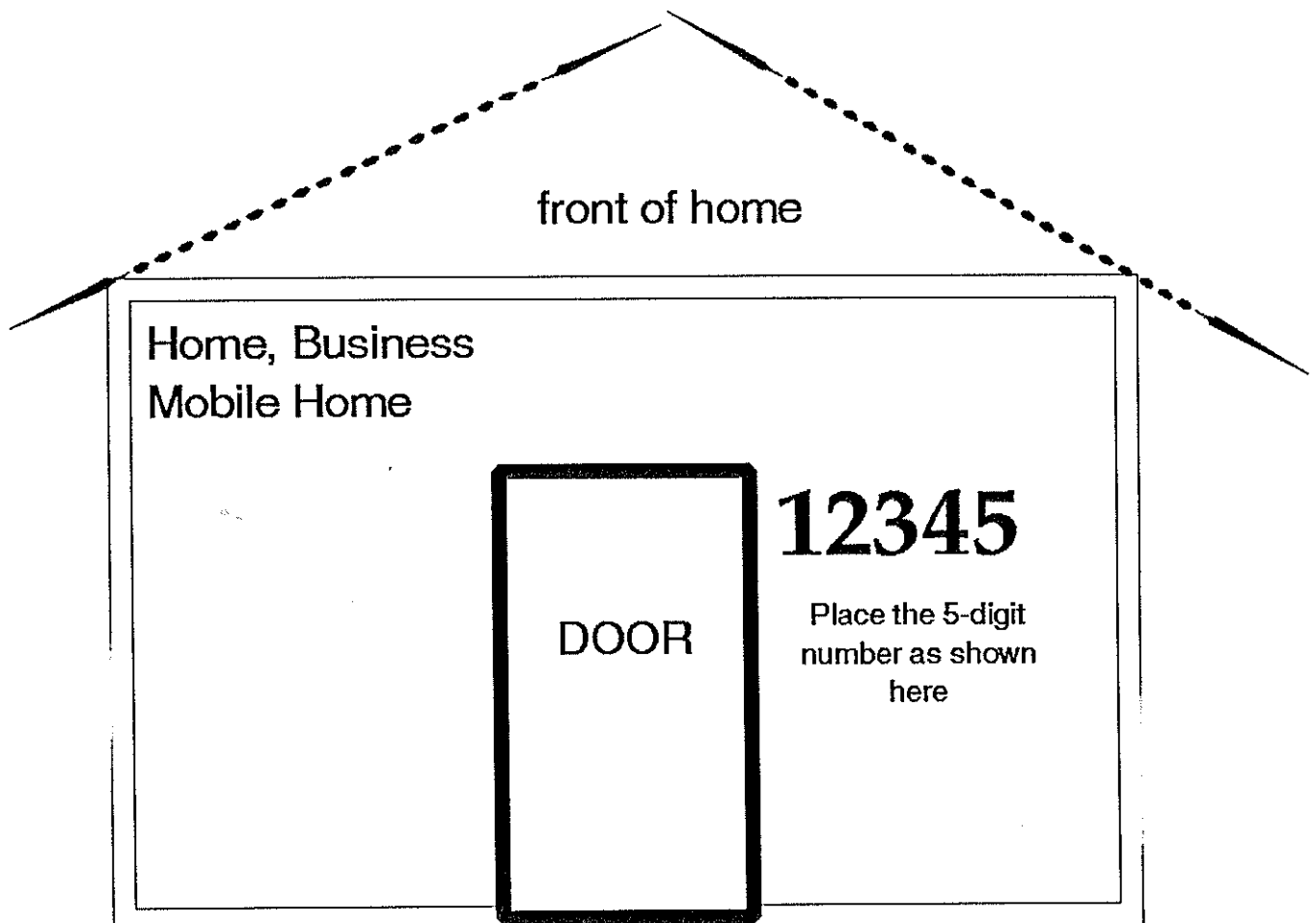
1. EVERYONE SHOULD BE REQUIRED TO POST THIS NUMBER ON THE SIDE/FRONT OF THEIR HOUSE/TRAILER IN PLAIN VIEW, FROM THE MAIN ROAD.
2. THIS NUMBER SHOULD ONLY BE THE FIVE DIGIT NUMBER.
EXAMPLE 1 2 4 6 8 (NO STREET NAMES, ECT)
3. THESE NUMBERS SHOULD BE AT LEAST THREE INCHES TALL.
4. THERE SHOULD BE A SMALL FINE (\$25.00) ENFORCED TO PERSONS WHO DO NOT COMPLY WITH THIS ORDINANCE.
5. THERE SHOULD BE A TIME LIMIT ON POSTING THE NUMBERS.

Directions for Posting Street #'s

The 5-digit number to be posted is your address as issued by the United States Postal Service. The numbers should be at least three inches tall and should be posted on the home, business or mobile home adjacent to the front door on the righthand side, as YOU face the front door. The height should be six feet above the level of the door. **POST ONLY THE STREET NUMBER!** No Street names etc... The numbers used can be of any type of material, but must be clearly visible from the street.
