Notable Accomplishments



Same As U opened in January of 2020 serving 8 young adults with developmental disabilities in borrowed space within the walls of White River Christian Church in Noblesville. Despite a global pandemic, Same As U continued to grow and reached capacity by the summer of 2022. The steady growth in enrollment indicates demand for not only this type of programming and environment, but also the level of care that is being provided by Same As U instructors. At the close of 2022, 63 young adults with developmental disabilities refer to Same As U as their college and the growth continues.

In the fall of 2021, Same As U began a 3 year Generosity Campaign to raise necessary funds to purchase their future campus. The campaign included the cost to purchase the building and 5.6 acres of land located at 19201 Promise Road. It also included funds to cover the needed renovations and to equip the space for programming.

By the true grace of God, the goal was met and Same As U closed on their forever home mortgage free in June of 2022. Renovations began in September of 2022 and on January 9th of 2023, Same As U students arrived at their new college campus ready to learn, engage, and be reminded that they are loved and have a purpose and a plan!

The students are thriving in their new college campus and there is room to grow and continue welcoming more young adults that need this type of joy-filled, life-giving environment. Same As U continues to dream big for our students and is excited for what the future hold!

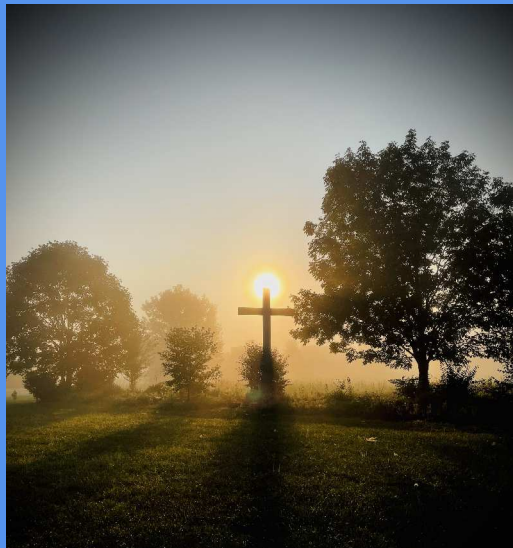

Same As U began a 3 year \$1.65 Million Capital Campaign in the fall of 2021. The campaign also factored in funding to cover 2 years of Annual Building Cost. By year 3 after closing, Same As U will begin to cover the Annual Building Cost with SAU's operating budget.
